The following documents will be very helpful as you prepare to fill out the loan application. The information on the loan application can be found in these documents. CONVENTIONAL/FHA

- Last two years W-2s
- Last two years tax returns (if self-employed)
- Most recent pay stubs covering 30 days
- Most recent two (2) bank statements for all saving/checking accounts
- Rental agreements for all rental properties owned
- Supporting documentation to verify any other type of income listed above
- Earnest money agreements (purchasing only)
- Bankruptcy or divorce documents
- Copy of photo identification

VA

- Same as above PLUS discharge papers (DD214) and Certificate of Eligibility
